SPECIFIC CONDITIONS

1. This Integrated Consent to Operate is granted subject to the power of the Board to review and make variation in all or any of the conditions laid hereunder.
2. For renewal of the consent in case of continuance of discharge/operation of the industry, application in the prescribed form shall be submitted through the web portal of the Board(keralapcbonline.com) 2 months prior to the date of expiry. Late application will be accepted only with fine.
3. Any change in particulars furnished in the application and/or in the identity of the occupier/ authorized agent is to be intimated to the Board forthwith.
4. The applicant shall comply with all instructions that the Board may issue from time to time regarding prevention and control of air, water, land and sound pollution
5. The quarry should not be operated between 6.00 p.m. and 6.00 a.m.
6. Noise measured 1 m outside the boundary of the premises shall not exceed the limit specified for the area under the Ambient Air Quality Standards in respect of noise.
7. The concentration of particulate matter PM 10 and PM 2.5 at the boundary of the premise shall not exceed 100 microgram/m³ and 60 microgram/m³ respectively.
8. Permanent fence made of wire mesh shall be provided and maintained along the boundary of the approved quarry area.
9. The applicant shall put up a 6 ft. x 4 ft. signboard near entrance to the quarry for displaying the name of the quarry and owner, production details and time of the day when blasting is permitted to be undertaken.
10. Location and extent of quarry shall be as per the approved site plan attached.
11. After completion of quarrying, the land may be reclaimed as per the mining plan approved by the Department of Mining and Geology.
12. Quarrying operations shall be started only after obtaining the all the statutory clearances required, which shall be valid throughout the period of operation.
13. This consent is issued based on EC no. EC24B001KL152868 dated 03/03/2024 and valid for 5 years starting from the date of issue of Mining permit from the kozhikode District department of mining and geology.
14. This consent is granted on the basis of the site plan and affidavit and Location sketch from village officer furnished by the applicant is liable to be revoked if any statement is found false on verification.
15. A minimum distance of 50 m shall be kept from the boundary of quarry area to residential buildings, places of worship, public buildings, public road having vehicular traffic, river or lake, railway line and bridges.
16. The depth of excavation below the highest point shall not exceed 6m. Bench cutting shall be practiced.
17. Blasting shall be done at specified time with prior signals to avoid accidents.
18. No other machinery shall be operated without prior Consent of the Board.
19. Quarrying operations shall be started only after obtaining Mining permit/lease from Mining & Geology Department and D & O License under the Kerala Panchayat Raj Act from the concerned Local Self Government.
20. Proper fencing/barriers shall be provided and maintained all around the abandoned deep quarry pits to avoid accidents
21. Blasting and quarrying shall be done without causing any nuisance or damage to occupants of adjoining or neighbouring land or building or posing damage to health, life or property.
22. The applicant shall submit copies of all relevant permits/lease/certificate/licenses periodically to this office to ensure the validity of this consent and this consent is issued based on following documents.


